The Thalatta Estate Catering Permit must be completed by any Renter and Caterer who intends to use the on-site facility to provide food service at the request and expense of Renter. The Village of Palmetto Bay must first give the Renter permission to use an authorized and licensed caterer. If approved, it is the renter's responsibility to obtain the Caterer's signature on this permit and provide a copy of Certificate of Liability Insurance demonstrating the Village of Palmetto Bay as an additional insured/certificate holder. It is the Renter's responsibility to obtain proof that the Caterer meets Village of Palmetto Bay's insurance requirements.

Caterer is responsible for clean up during and after the event. caterer cannot, for any reason, provide full clean up, Permittee and/or Caterer is responsible for contracting a clean up service Caterer is responsible for obtaining all required food distribution licenses or permits and fully complying with applicable federa state, local laws and regulations as well as all pertinent Village of Palmetto Bay ordinances and policies. Copies of all sair permits and/or licenses must be attached and submitted with executed permit application.  Caterer and Renter shall indemnify and hold harmless the Village of Palmetto Bay, its officers, agents, and employees, fror and against any and all claims, damages, costs, claims for loss or damage to any property, or for death or injury to any perso or persons.  Caterer, at its sole cost and expense, must insure its activities, including but not limited to general liability, products, auto, an liquor liability and the Village of Palmetto Bay specifically named as additional insured. At least one (1) month prior to the dat for usage of Village of Palmetto Bay facilities, Caterer and/or Renter must furnish the Village of Palmetto Bay with currer certificate of liability insurance showing caterer's compliance with mandatory Village of Palme
